2.3. Other hazards

Static accumulating flammable liquid can become electrostatically charged even in bonded and grounded equipment. SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a poison centre or doctor/physician if you feel unwell.

7.1. Precautions for safe handling

Store in tightly closed container. Store in a well-ventilated place. Keep in an area equipped with sprinklers. Store away from incompatible materials (see section 10 of the SDS).
