Methods and materials for containment and cleaning up

ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Extinguish all flames in the vicinity. Keep combustibles (wood, paper, oil, etc.) away from spilled material.

Large Spills: Stop the flow of material, if this is without risk. Dike spill for later disposal.

Small Spills: Sweep or shovel up material and place in a clearly labeled container for waste. Following product recovery, flush area with water. Prevent product from entering drains. Do not allow material to contaminate ground water system. Clean surface thoroughly to remove residual contamination.

Environmental precautions
