F. Deduct \$.015 per degree API for each 1/10 degree above 60.0 deg. API.

G. Deduct \$.015 per degree API for each 1/10 degree above 60.0 deg API.

Deduct \$0.02 per degree API for each whole degree below 40.9 degree API to 35.0 degree API.

Deduct \$0.015 per degree API for each 1/10 degree below 35.0 degree API.

H. Deduct \$.015 per degree API for each 1/10 degree above 60.0 deg. API.

Deduct \$.015 per degree API for each 1/10 degree below 34.0 deg. API.

I. Deduct \$.015 per degree API for each 1/10 degree above 60.0 deg. API.

Deduct \$.015 per degree API for each 1/10 degree below 40.0 deg. API.

J. Deduct \$.010 per degree API for each 1/10 degree above 60.0 deg. API.

Deduct \$.005 per degree API for each 1/10 degree below 29.0 deg. API and above 25.0 degree API.

Deduct \$.010 per degree API for each 1/10 degree below 25.0 deg. API.
