**B.** Deduct \$0.02 per whole degree API for each whole degree API from 40.9 degree API to 35.0 degree API.

Deduct \$.015 per 1/10 degree API for each 1/10 degree below 35.0 degree API.

Deduct \$0.15 per degree API for each whole degree above 44.0 degree API.

**C.** Deduct \$0.02 per degree API for each whole degree below 29.9 degree API

**D.** Flat

**E.** Deduct \$0.02 per degree API for each whole degree below 40.9 degree API

**F.** Deduct \$.015 per degree API for each 1/10 degree above 60.0 deg. API.

**G.** Deduct \$.015 per degree API for each 1/10 degree above 60.0 degree API.

Deduct \$0.02 per degree API for each whole degree below 40.9 degree API to 35.0 degree API.

Deduct \$0.015 per degree API for each 1/10 degree below 35.0 degree API.

**H.** Deduct \$.015 per degree API for each 1/10 degree above 60.0 deg. API.

Deduct \$.015 per degree API for each 1/10 degree below 34.0 deg. API.
