Deduct \$0.015 per degree API for each 1/10 degree below 35.0 degree API.
- H. Deduct \$0.015 per degree API for each 1/10 degree above 60.0 deg. API.
Deduct \$0.015 per degree API for each 1/10 degree below 34.0 deg. API.
